1. MEMBERSHIP AFFILIATION FEES

2. MEMBER ASSOCIATION ANNUAL FEE FORMULA¹

Membership Fee Formula for 2022

In addition to the Membership Affiliation Fee, the Annual Membership fee for Member Associations is calculated by a formula approved by Special Resolution at a Meeting of the Members. The current approved formula is: Total number of registered players of the current year multiplied by \$9.00. The fee is payable in two payments:

- a) The first instalment payment, is due on May 1 and will be calculated at 80% of 2019 registered players multiplied by \$9 multiplied by 85% (2019 registered players x \$9 x 80% x 85%).
- b) The final payment, due on November 1, is the current year's total fee less any instalment already paid in May.

Membership Fee Formula for 2023

In addition to the Membership Affiliation Fee, the Annual Membership fee for Member Associations is calculated by a formula approved by Special Resolution at a Meeting of the Members. The current approved formula is: Total number of registered players of the current year multiplied by \$9.00. The fee is payable in two payments:

- a) The first instalment payment, is due on May 1 and will be calculated at 80% of the prior year's fee.
- b) The final payment, due on November 1, is the current year's total fee less any instalment already paid in May.

- a) Provincial Only **50% of Clinic Fees**

5. REINSTATEMENTS

- a) All applications for reinstatements must be made through the Provincial/Territorial Association with which the player is registered and Submitted to Canada Soccer. **\$500.00**

6. APPEALS

- a) A certified cheque or money order to be forwarded to the CSA by the Applicant. **\$1 500.00 + costs**

7. APPLICATION FOR TRAVEL

- a) For all teams applying for travel outside Canada (except to USA) **\$100.00**

8. APPLICATION FOR EXHIBITION GAMES SANCTIONING

- a) Application Fee **\$100.00**
b) Promoter Performance Bond **\$25,000.00**
c) Sanctioning Fees regarding exhibition games involving *foreign teams*, are:
i. Games involving a Professional Club in Membership as a % of gross gate receipts (including taxes) **8%**
ii. Games involving non-member clubs as a % of gross gate receipts (including taxes) **10%**

9. INTERNATIONAL AMATEUR CLUB FRIENDLY TOURNAMENTS

- a) Administrative Fee **\$100.00**

10. OUTSTANDING INVOICES

- a) 3% interest per annum applied to outstanding levies and all invoices over 30 days. No interest will be charged if payment is received within 30 days of the date of the invoice.
b) Payment for Travel Costs for National Club Championships to be received immediately upon receipt of invoice (7 days grace accorded).

11. INTERMEDIARY PRE-REGISTRATION
