### 2. MEMBER ASSOCIATION ANNUAL FEE FORMULA<sup>1</sup>

#### Membership Fee Formula for 2024

In addition to the Membership Affiliation Fee, the Annual Membership fee for Member Associations is calculated by a formula approved by Special Resolution at a Meeting of the Members. The current approved formula is: Total number of registered players of the current year multiplied by \$9.00. The fee is payable in two payments:

- a) The first instalment payment, is due on May 1 and will be calculated at 80% of the prior year's fee.
- b) The final payment, due on November 1, is the current year's total fee less any instalment already paid in May.

#### Membership Fee Formula for 2025

In addition to the Membership Affiliation Fee, the Annual Membership fee for Member Associations is calculated by a formula approved by Special Resolution at a Meeting of the Members. The current approved formula is: Total number of registered players of the current year multiplied by \$13.00. The fee is payable in two payments:

- a) The first instalment payment, is due on May 1 and will be calculated at 80% of the prior year's fee.
- b) The final payment, due on November 1, is the current year's total fee less any instalment already paid in May

Beginning in 2025, \$0.50 of each \$1.00 of the Membership Fee will support the Northern Super League and \$0.50 of each \$1.00 of the Membership Fee will support Youth National Team budgets.

## **10. OUTSTANDING INVOICES**

- a) 3% interest per annum applied to outstanding levies and all invoices over 30 days. No interest will be charged if payment is received within 30 days of the date of the invoice.
